2019 UK VISA — Requirements —

1. Valid International Passport (Minimum of 6 months validity)
2. One recent passport sized color photograph (3.5 x 4.5 mm white background).
3. Previous International Passports (If any).
4. Evidence of Marital Status (Marriage Certificate).
5. Evidence of current employment (Letter on employer's letter headed paper showing you are in their employment, permission to attend the course, pay slip, tax returns etc.)
6. Hotel reservation.
7. Applicant's six months accounts statement from the bank.
8. Visa application fee of 85 (British pound sterling)
9. Visa application form (to be completed on-line).
10. Original and photocopy of all documents.
11. Travel booking confirmation (can be E-mailed or copy of tickets).
12. Evidence of registration for the seminar (The Institute will provide backup documents).
